- **Tender fees of the above tender:** QAR1,500/= to be paid in cash non-refundable.
- **Tender Bond amount and Validity Period:** the amount of Tender Bond should be not less than QAR 60,000/= (Qatari Riyals Sixty Thousand) and its validity period as mentioned above and to be issued by one of a first class reputable Bank operating in Qatar acceptable to QNCC, any Tender Offer not accompanied with the tender bond is subject to rejection.
- **Tender Offer's validity period:** the Tender Offer should be valid for a period not less than ninety (90) days, from the closing date & irrevocable during this period.
