- Tender Offer should be accompanied with a Tender Bond as stated above, to be issued by one of a Bank operated in State of Qatar, and the successful Tenderer is required to submit a bank guarantee/bid bond and its amount equal to 10% of the offered price and acceptable to QNCC.
- The Tenders and Procurement Committee (T&PC) has the right to reject any Tender Offer delivered after the closing date referred in above or not accompanied with Tender Bond.
- At the Company's desire during the effective/validity execution period of the final Contract, may request to increase or decrease the total Contracted quantities required within the limits of no more than 20% in accordance with the same Contract's terms, conditions & prices.
- Tender Offer should be valid for a period not less than ninety (90) days, from the closing date & irrevocable during this period.
- Tender Offer should be submitted in three (3) separate wax-sealed envelopes as follows: (First envelope containing only Tender Bond, the second envelope containing the technical specifications and the third envelope containing the financial & commercial prices) all shall be placed together in an outer big wax-sealed envelope, and to be addressed to the Chairman of Tender and Procurement Committee (T&PC). And should be indicate on the envelopes the Number, Title and Closing Date of the Tender. The Offer should be handed-over to the Tender & Procurement Committee office, Administration Building at Umm-Bab. The received Tender Offer will be deposited in respective Tender Box.
