- Tender Offer for each of the Tender should be accompanied with a Tender Bond as stated above, to be issued by one of a Bank operated in State of Qatar, and the successful Tenderer is required to submit a bank Guarantee/Bid Bond as per the provision mentioned in the Tender Documents of Tender.
